APPLYING TO BECOME A HOST FAMILY

The Central Okanagan School District values and respects the contribution made by families in our community who host international students. We feel Homestay is an important aspect in promoting student success and are pleased to be able to offer this program to our international students.

Homestay is a wonderful opportunity to share our culture with others and to learn about other cultures in return. Students come to our district from a number of countries in Asia, Europe, Central and South America.

GENERAL INFORMATION:

As the program objective is for English acquisition, it is an expectation of visiting foreign students that English will be spoken in the home in order to provide an immersion environment.

Length of placement: Full year, short term, summer and winter programs are available

Student Ages: Elementary, secondary, and adult

Homestay Fees: \$750 per month

Arrival Dates: September and January for secondary school academic studies,
On-going intake for short term, summer and winter programs.

APPLICATION PROCESS:

- Step 3: School District 23 (Central Okanagan) requires all applicants to submit a Criminal Record Search and a clearance from the Child Abuse Registry for all members of the household who are 19 years of age or older. Forms are available at the Kelowna RCMP detachment at 350 Doyle Avenue between the hours of 8:30 am and 4:30 pm Monday through Friday. This service has a cost of approximately \$40. Please bring your drivers' license and one other piece of government issued identification such as your care card or your passport.
- Completed forms will be sent in confidence directly to the International Education Program office.
- Step 4: Once your completed application form, Criminal Records Search and letters of reference (see pages 8 and 9 of the application) are received at our office, you will be contacted to arrange for a home visit.
- Step 5: Please review the International Education Program Host Family Guidelines (available on line). These will be reviewed with you during the home visit. At that time, Form B (Host Family Expectations) will also be reviewed with you and your signatures obtained.
- Step 6: You will be informed once a student match for your family is found. Student information will be made available to your family and we encourage host families to communicate directly with their student prior to their arrival.

Please allow 3 weeks for processing of your application.

CRIMINAL RECORDS SEARCH:

STATEMENT OF INTENT:

- I will abide by the expectations outlined in Form B which forms part of this agreement;

- If assigned a student, I agree to have my name published in a Homestay listing which is for the private use of Homestay families only;

HOST FAMILY EXPECTATIONS FORM B

Our host families are a very important component in the success of our international student program. Please take the time to review carefully the expectations outlined below before the home visit. If you and your family feel that you would like to proceed with the application process, please complete this form.

We endeavour to select families who we believe “match” well with the students who have applied to our program. If the district accepts your application, it does not guarantee that a student will be placed with you immediately. While we may recommend a placement, the final placements are based on the approval of the student’s family, agent or custodian. In the event that a placement is discontinued, for any reason, the district is under no obligation to replace the student for the balance of the school year.

If the student is assigned to your home, you agree that you will accept and comply with the terms outlined below. You further agree that you understand that breach of any of these terms may result in termination of the Homestay placement.

We, the host family agree that we will abide by the guidelines for Homestay placement as outlined on pages 5-7 of this application, and also specifically that:

1. We will provide to the student a private room that includes a window, bed, dresser, closet, table lamp, and desk, access to laundry and bathroom facilities. For high school students, we understand that a computer and internet access is preferred;
2. We will provide 3 well balanced, nourishing meals each day plus snacks to the student;
3. We will pick up the student from the airport at the beginning of the study period and return him/her to the airport on their return to their home country;
4. We will provide transportation to and from extra-curricular activities;
5. We will notify our household insurance company that we have an international student in residence and agree that we will carry a minimum of \$1 million liability insurance. A copy must be presented at the home inspection. Alternatively, proof of renters’ insurance is required.
6. We will carry at least \$2 million liability automobile insurance’
7. We will have the designation “to and from school” (if applicable) included on our automobile insurance;
8. We will never permit the international student to drive the family motor vehicle(s) for any reason;
9. We will contact the Supervisor immediately should significant problems with the student arise. Such problems might include failure to attend school, illegal drug or alcohol use, or emotional issues;
10. We will inform the supervisor immediately of any changes in our family composition, contact information or changes with respect to who is residing at the residence;
11. We will obtain all permission required for travel outside the district;
12. We will review household rules and expectations promptly upon the arrival of the student;
13. Upon arrival of the student, we will provide the student with house keys, information on how to use the house alarm and instruct the student on the course of action in the event of a fire, earthquake or other emergency. We will also instruct the student on the procedure for dialling 911 and what such a call entails;
14. We will instruct the student on the legality of seat belt use and bicycle helmet. If the student uses a bicycle, we will make arrangements for the purchase of a helmet;
15. We will make reasonable efforts to be familiar with the whereabouts of our student at all times;
16. We will ensure that the student attends school regularly;
17. We will act as a judicious, caring parent and treat the international student as a member of the family.
